

Educators Credit Union Contest Official Rules

The following apply to promotional contest opportunities Educators Credit Union (also referred to as Educators, Credit Union, or the credit union within this document). Unless otherwise denoted, the promotional sponsor of all giveaways, contests, and other sweepstakes is Educators Credit Union located at 1326 Willow Road, Mt Pleasant, WI 53177.

Program Description & eligibility: NO PURCHASE / PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN CONTESTS

OR GIVEAWAYS. Promotions are open to members of

Educators Credit Union, also referred to as "the credit union," age 18 and over at the time of drawing, located in any state of the United States of America.

Members must be deemed in good standing to be eligible to win.

Employees and officials of the credit union are not eligible. Void where prohibited by law. The account must be in good standing the day of any drawing, to receive the prize. An account is not in good standing if its checking account has been negative for more than 35 days or a loan is overdue for payment.
